



SCAD 2023: PROSEC Excellence Awards for Students and Dental Professionals

Houston, TX – April 2, 2023

Dear Colleagues:

The Society for Color and Appearance in Dentistry (SCAD, www.scadent.org) is pleased to announce PROSEC Excellence Award for the best clinical and research poster at our 14th Annual Conference (November 10-11, Chicago Marriott Downtown Magnificent Mile). US/international students (graduate/undergraduate) and dental professionals (with 10 or fewer years in practice/below the level of Associate Professor), are eligible for this award. The content should be related to color, esthetics and other aspects of ceramic restorations while emphasizing team work.

Application Process: Applicants are required to submit an application and abstract following the instructions provided at the SCAD website by September 1, 2023. The Award Committee will review the applications based on perceived merit, feasibility, and relevance, and send acceptance/rejection notice to all applicants. All applicants must preregister and attend the annual meeting. The awardees will be announced at the meeting.

Award: The author of each accepted abstract will receive a complimentary registration for the 2023 SCAD meeting and free hotel accommodation (up to two nights). The winners in student and dental professional category will also receive a complimentary registration for SCAD 2024.

Eligibility: Only one award per category will be given annually, and only one award per recipient can be received (previous recipients are not eligible).

Awardees' Obligation: Any manuscript generated from recipient's work must be submitted to the Journal of Esthetic and Restorative Dentistry, to be considered for publication. Proper acknowledgment of the support provided from the Society for Color and Appearance in Dentistry and PROSEC Award must be cited in the presentation and subsequent publication/s.

Review Guidelines: Each abstract will be reviewed, and will be judged and scored based on the following criteria:

| 3. Originality and vision | 25 points |
| 4. Potential for generating new information or concepts | <u>25 points</u> |

Total Possible Score: 100 points

Every effort will be made to avoid conflicts of interest. Members of the Executive Board will not be allowed to review or vote on applications submitted by faculty or students from their institution (employee or graduate thereof).

Regarding confidentiality, all materials distributed will be held in strict confidence. Moreover, all deliberations, comments, recommendations, or results of the selection process will be held in confidence by the reviewers until the official announcement has been made and the award recipients have been notified.
